28	TO ESTABLISH THE WATER AND SEWER			
29	TREATMENT FACILITIES GRANT PROGRAM; AND

32	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

34	SECTION 1. Arkansas Code Title 19, Chapter 5, Subchapter 12, is			
35	amended to add an additional section to read as follows:			
36	19-5-1288. Water and Sewer Treatment Facilities Grant Program Fund.			

1	(a) There is established on the books of the Treasurer of State, the
2	Auditor of State, and the Chief Fiscal Officer of the State a miscellaneous
3	fund to be known as the "Water and Sewer Treatment Facilities Grant Program
4	<u>Fund".</u>
5	(b) The fund shall consist of any revenues authorized by law.
6	(c) The fund shall be used by the Arkansas Natural Resources
7	Commission to award grants under the Water and Sewer Treatment Facilities
8	Grant Program established in § 25-43-203.
9	
10	SECTION 2. Arkansas Code Title 25, Chapter 43, Subchapter 2, is
11	amended to add an additional section to read as follows:
12	25-43-203. Water and Sewer Treatment Facilities Grant Program.
13	(a)(1) There is created within the Arkansas Natural Resources
14	Commission the Water and Sewer Treatment Facilities Grant Program to be
15	administered by the commission.
16	(2) The commission may hire personnel necessary to carry out the
17	duties of administering the program.
18	(b) The commission shall:
19	(1) Create an application form to be submitted by eligible water
20	and sewer treatment facilities seeking a matching grant from the program;
21	(2) Devise an application process that:
22	(A) Defines the eligibility criteria for a matching grant;
23	<u>and</u>
24	(B) Establishes application submission and review
25	processes;
26	(3) Define a process by which grants may be awarded;
27	(4) Execute standard legal grant agreements and other
28	documentation governing the disbursement and use of grants; and
29	(5) Provide a matching grant to eligible water and sewer
30	treatment facilities for infrastructure and improvement projects that are
31	shovel-ready.
32	(c) A recipient of a grant awarded under this section shall:
33	(1) Begin the recipient's project within one (1) year of the
34	award of the grant funds; and
35	(2) Not be eligible for another grant until the awarded grant
36	has been closed out.

1	(d) Funding under the program shall be awarded as follows:		
2	(1) Eighty percent (80%) shall be awarded for shovel-ready		
3	projects in:		
4	(A) Cities of the first class and cities of the second		
5	class with a population over one thousand two hundred (1,200); or		
6	(B) Rural water and rural wastewater systems serving a		
7	population over one thousand two hundred (1,200); and		
8	(2) Twenty percent (20%) shall be awarded in:		
9	(A) Incorporated towns and cities of the second class with		
10	a population of one thousand two hundred (1,200) or less; or		
11	(B) Rural water and rural wastewater systems serving a		
12	population of one thousand two hundred (1,200) or less.		
13	(e) The commission shall promulgate rules to implement this section.		
14	(f) The program shall expire five (5) years from the effective date of		
15	this act.		
16	(g) The commission shall report annually to the Legislative Council		
17	or, if the General Assembly is in session, the Joint Budget Committee,		
18	regarding the status of all grants awarded under the program.		
19			
20	SECTION 3. EMERGENCY CLAUSE. It is found and determined by the		
21	General Assembly of the State of Arkansas that it is in the best interest of		
22	the citizens of this state to provide water and sewer grant opportunities for		
23	projects to keep Arkansas water systems safe and clean; and that this act is		
24	immediately necessary because there is a dire need to protect public health		
25	and safety in Arkansas by replacing water and sewer lines that are in		
26	disrepair and by providing new access to clean water systems to other		
27	citizens. Therefore, an emergency is declared to exist, and this act being		
28	immediately necessary for the preservation of the public peace, health, and		
29	safety shall become effective on:		
30	(1) The date of its approval by the Governor;		
31	(2) If the bill is neither approved nor vetoed by the Governor,		
32	the expiration of the period of time during which the Governor may veto the		
33	bill; or		
34	(3) If the bill is vetoed by the Governor and the veto is		
35	overridden, the date the last house overrides the veto.
